- 1. BASE FEE includes 1 inspection \$70.00
2. Air Conditioning Residential/Commercial under 5 H.P. \$25.00
3. Commercial - Over 5 H.P. per System \$45.00
4. Roof Top Units: New - Requires Engineer Report \$45.00
5. Boiler Commercial: Requires State permit \$20.00
6. Furnaces, (Excludes Venting, Gas Pipe & Ducting) \$15.00
7. Water Heater added at time of Boiler or Furnace change out \$15.00
8. Gas Piping: Each Gas Meter System/per floor/or add on piping \$20.00
9. Vent Systems, B-vent, all Fuel, Metal, Liners, Pellet etc \$15.00
10. Commercial Duct Systems: Each separate system per floor/per unit \$40.00
11. Residential Duct Systems: Per Unit \$20.00
12. Air Handling Unit: any piece of equipment that moves air and not classed as an air conditioner, furnace, variable air volume box, bath fans or zone device \$20.00
13. Commercial Hood/Kitchen Grease Ducts in same room with make-up air \$50.00
14. Commercial Ventilation not a portion of any Heating or Air Conditioning System \$35.00
15. Unit Heaters, Wall Heaters - Vented/Un-vented Includes Piping & Venting \$30.00
16. Walk in/Reach in Coolers, includes Compressor, Line Sets, etc \$40.00
17. Any Appliance or piece of Mechanical Equipment regulated by the State Code not Classed in any other Categories & for which no other fee is listed \$20.00
18. Additional Inspection Fee each over 1 or Investigation Fee \$65.00
19. Process Piping / Hydronic Commercial \$75.00
20. Process Piping / Hydronic Residential \$20.00

This is not your Permit! The Permit will be issued only after approval of the Division. Work shall NOT be commenced until the Mechanical Contractor receives the Permit, unless prior approval to start work is obtained by the Mechanical Official.

HOMEOWNER'S AFFIDAVIT

Registration of Mechanical License (Each new or renewed License.....) \$15.00

Refund of Fees: Holders of permits upon which work has not been started may make written application for a refund of Fees paid for such Permits, provided such application is made and attested before a notary public by the same person or corporation who originally applied for such permit or by the estate of such person or receiver of such corporation within six (6) months of date of issue. Upon verifying the facts in such cases, the Building Safety Manager shall refund seventy-five percent (75%) of all fees in excess of five dollars (\$5.00) in such manner as may be directed by the City Controllers.

Investigation fee: Whenever any work for which a permit is required by Code has been commenced without first obtaining said permit, a special investigation shall be made before a permit may be issued for such work. An investigation fee, in addition to the permit fee, shall be collected whether or not a permit is then or subsequently issued. The payment of such investigation fee shall not exempt any person from compliance with all other provisions of the Code nor from any penalty prescribed by law.
