CITY OF LANSING ELECTION COMMISSION  
RESOLUTION TO CONSOLIDATE PRECINCTS FOR THE SCHOOL SPECIAL  
ELECTION TO BE HELD ON TUESDAY, MAY 4, 2021

WHEREAS, Holt Public Schools, Waverly Community Schools, and Okemos Public Schools have both called special elections for May 4, 2021, and

WHEREAS, Waverly Community Schools has land area in the City of Lansing in Ward 4 Precinct 36 and Ward 4 Precinct 40 with no registered voters; and

WHEREAS, Okemos Public Schools has land area in the City of Lansing Alaieton Township 425 area in Ward 2 Precinct 18 with no registered voters; and

WHEREAS, the City of Lansing anticipates a low voter turnout for the School Special Election on May 4, 2021; and

WHEREAS, the City of Lansing must be able to accommodate same day registration for any voter living in the district; and

WHEREAS, MCL 168.659 allows for the City Election Commission to consolidate two or more precincts in school special elections, provided the new consolidated precinct does not exceed 5,000 registered voters; and

THEREFORE, BE IT RESOLVED that the following precincts be consolidated for the May 4, 2021 School Special Election:

4-36, 4-40 and 4-41 voting at Cumberland School  
2-18 and 2-20 voting at Henry North School
